## TREE PLANTING MACHINE RENTAL AGREEMENT

The undersigned \_\_\_\_\_, Licensee, hereby rents and leases from the Dunn County Land and Water Conservation Division, Licensor, one tree planting machine, subject to the following terms and conditions:

1. The Licensee shall pay to the Licensor the sum of **\$75.00 for one day of use** of said tree planting machine, **\$125.00 for two days of use**, and **\$150.00 for three days of use**. These rental rates include a sales tax of 5.5% as per Wisconsin Administrative Code 11.05. **This agreement assumes that up to 5,000 trees can be planted per day.** The Licensee shall furnish all necessary labor, supplies, and power required in the operation and movement of said tree planting machine while in the Licensee's possession.
2. The Licensee shall return said tree planting machine when no longer required by the Licensee or whenever demanded by the Licensor in as good condition and in repair as when delivered to Licensee, ordinary wear and tear excepted. It shall be lawful for the Licensor or its Agents to enter upon the premises of the Licensee at any time to secure the return of said tree planting machine.
3. The Licensee assumes and agrees to pay for all loss or damage to property and injury to or death of persons, including costs and expenses therein arising, wholly or in part, from or in connection with the said use, transportation, operation, maintenance, or repair of said tree planting machine or any defect therein of failure thereof causing same or contributing thereto, and the Licensee shall forever indemnify the Licensor against and save it harmless from all liability for any incident thereto.
