

ORDINANCE NO. 169
SOLID WASTE/RECYCLING MANAGEMENT SYSTEM AND BOARD

The County Board of Supervisors of the County of Dunn does hereby ordain as follows:

2.03 (1) PURPOSE. The intent of this Ordinance is to establish a Solid Waste and Recycling Management System for the County of Dunn to include a Solid Waste/Recycling Management Board to operate the system, all pursuant to Chapters 59 and 159 of the Wisconsin Laws.

2.03 (2) SOLID WASTE/RECYCLING MANAGEMENT BOARD.

(a) The Dunn County Solid Waste/Recycling Management Board is created and shall be composed of nine residents of Dunn County, who are persons of recognized ability and demonstrated interest in the problems of solid waste and recycling management, and five of those members shall be members of the Dunn County Board of Supervisors.

(b) Appointments to the Dunn County Solid Waste/Recycling Management Board shall be made by the Chairman of the Dunn County Board of Supervisors with approval of the entire board of county supervisors. The term of office for each member of the Dunn County Solid Waste/Recycling Management Board shall be a period of three years, except that of the members first appointment, three shall be appointed for a period of one year; three appointed for a period of two years; and three appointed for a period of three years.

(c) Vacancies on the Dunn County Solid Waste/Recycling Management Board shall be filled for the residue of the unexpired term in the manner of the original appointment.

(d) Any member of the Dunn County Solid Waste/Recycling Management Board may be removed from office by two-third's vote of the Dunn County Board of Supervisors present and voting.

2.03 (3) POWERS OF THE SOLID WASTE/RECYCLING MANAGEMENT BOARD. The Board may:

(a) Employ a Solid Waste/Recycling Coordinator and such assistants who are trained and experienced in solid waste and recycling management.

(b) Develop and institute plans for a solid waste/recycling management system and provide for a public education program regarding solid waste and recycling management.

(c) Collect, transport, dispose of, destroy or transform waste and recyclables, including, without restriction because of enumeration, garbage, ashes, or incinerator residue, municipal, domestic, agricultural, industrial and commercial rubble, waste, recyclables or refuse material, including explosives, pathological waste, chemical waste, herbicide and pesticide waste.

(d) Acquire lands by purchase, lease, donation or eminent domain, within the county, for use in the Solid Waste/Recycling Management System.

(e) Authorize its employees or agents to enter upon lands to conduct reasonable and necessary investigations and tests to determine the suitability of sites for Solid Waste/Recycling Management activities whenever permission is obtained from the property owner.

(f) Acquire by purchase, lease, donation, or eminent domain such easements or other limited interests in land as are desired or

needed to assure compatible land uses in the environs of any site that is part of the Solid Waste/Recycling System.

(g) Establish operations and methods of Solid Waste and Recycling Management as are deemed appropriate.

(h) Acquire necessary equipment, use equipment and facilities of the County Highway Department with its approval, and construct, equip and operate structures to be used in the Solid Waste/Recycling Management System, said expenditures not to exceed \$50,000 per item without approval of the Dunn County Board of Supervisors.

(i) Enforce ordinances necessary for the conduct of the Solid Waste/Recycling Management System.

(j) Contract with private collectors and transporters or municipalities to receive and dispose of waste and recyclables.

(k) Engage in, sponsor, or co-sponsor research and demonstration projects intended to improve the techniques of solid waste and recycling management or to increase the extent of reuse or recycling of materials and resources included within the waste. The Board may also develop a system for the collection, processing and marketing of all recyclables and also provide for the management of post consumer waste that is not and/or cannot be separated for recycling purposes.

(l) Accept funds derived from state or federal grants or assistance programs and enter into necessary contracts or agreements.

(m) Charge or assess reasonable fees, approximately commensurate with the costs of services rendered to the persons

using the services of the County Solid Waste/Recycling Management System. Fees may include a reasonable charge for depreciation which shall create a reserve for future capitol outlays for solid waste or recycling disposal facilities or equipment.

(n) Utilize or dispose of by sale or otherwise, any and all products or by-products of the Solid Waste/Recycling Management System.

This Ordinance shall take effect upon its passage and publication as provided in section 59.09, Wis. Stats.
